2023 Budget Review: Tanner Hiers

- The header needs to be changed to 2023. Tanner went over a few key points listed below.
- He left the income the same as last year. He increased the payroll category to include a 4% increase. He put \$5000 towards engineering as he would like get plans drawn up for a decant system (last year we used 0 for engineering). Chemicals were increased from last year to 26,000 and water analysis and testing also up to 16,700. Dams and watershed increased to \$18,000 because of all the trees and the measuring device for Cooksley. He budgeted \$65,000 for distribution as we need to re-surface Deer Park Tank. We were under budget on Operating and Gen and Admin expenses for 2022 so he lowered them a bit for 2023. Last year we were on a tight budget and this year he tightened it even more.

Report on Operations: Tanner Hiers

- **IFB**: The due date was today, and we received 3 contractor bids. They will be opened in separate meeting (after the regular meeting) with the Bid Committee. The Bid Committee is Frank Dotzler, Dave Wesner, Tanner Hiers and Shannon Damonte.
- **Bremer Easement:** We went to the county recorder and got a map that showing the property belonged to the Schultz's (referenced in an old easement) but there was no parcel number at that time and the map is a bit disproportionate. We need to do some title work to find out for sure. Greg can help Tanner with that and call John Tuteur or John Webb.
- **THM Removal System:** The equipment is now here and ready to install. Han Smith will schedule the divers and give us the final date for installation.
- State Grant Funds: The state is starting a new program to try and help with water systems to the tune of 130 million a year until 2030. They are trying to figure out how to get the money to the systems. Tanner is thinking we will be able to receive funds due to our MCL violations in The Human Right to Water (HR2W) criteria -Bill AB 685.
- **Leaks:** There was a leak in Nikki's front yard that was significant. Tanner found another valve so he didn't have to shut off a lot of people to fix it. There was also a leak at BRK-276.
